Pre -Registration Fee: \$40.00 (cash only) per team – due the day of the tournament.

Late Registration: \$50.00. If registering at the event, you must arrive by 8:30 AM.

Teams MUST register with 3 players per team, maximum of 4 players per team.

Each team must submit an entry form prior to March 24th for early registration. Player waiver forms must be completed by each player (regardless of age), signed by a parent or guardian and submitted the day of the tournament. No exceptions. Do not send any money through the mail. **Payment (CASH only) will be accepted the day of the tournament.**

Boys and Girls divisions (no coed teams):

5th to 6th grade, 7th to 9th grade, 10th to 12th grade. Participants must still be in school. Skilled players may play up to the next level, but higher grade levels may not play down.

Individuals may sign up on-site for our shooting contest. \$2 entry fee per person. Contest starts during registration and will run while brackets are being completed. There will be a concession stand open for business.

3 on 3 Tournament Rules

- 1. Teams must register with 3 players, maximum of 4. 3 players on the court at one time, substitutions permitted.**
- 2. ALL players must have a waiver signed by a parent/guardian regardless of age!**
- 3. Players may register for ONE team ONLY.**
- 4. ALL players must still be in school.**
- 5. Poor sportsmanship, fighting, and foul language will not be tolerated. You and your team will forfeit and leave school property. Booster club decisions are final.**
- 6. NO food or drink in the Gym. One exception – drinks while playing.**
- 7. NO jewelry while playing.**
- 8. Players must wear proper attire. No Jeans or street shoes.**
- 9. Coin flip to determine starting possession**
- 10. Double elimination, including Championship game. If the winner's bracket team suffers a first loss they must be given a rematch.**
- 11. All games play to 11, win by 2. Time limit may be set if there are more teams than expected.**
- 12. 5th and 6th grade games will have a time limit of 15 minutes.**
- 13. Time Limit Rules – When a time limit is reached, whichever team is in the lead is the winner. In the event of a tie, the first team to go ahead by 2 wins. At 20 minutes whichever team is ahead will win. If 20 minutes is reached and the score is still tied then we will go to extended overtime. If a team scores, the opposing team will get one possession to attempt a tie. If unsuccessful, the game is over.**
- 14. One point per basket, no 3 point shots.**
- 15. Change of possession after every basket - the ball must be brought back out to the top of the key after a possession change. One pass must be made before a shot is taken.**
- 16. Conduct your own game and call your own fouls. The court monitor is not a referee. If a disagreement can't be resolved, use a coin flip.**
